#### **Student Success**

#### A. Free & Low-Cost Housing -

Mike Bowers, Director of Student Housing gave an update to the Board.

- Student Housing has rolled out its inaugural Learning Community program, offering free housing to students registered full-time at EvCC.
- We're also working on a partnership with Housing Hope and Cocoon House that will provide free/reduced housing to unaccompanied homeless youth.
- Occupancy for the quarter is currently at 87%, which far exceeds last year's rates and is higher than most two-year colleges in the area

### B. Student Debt -

Shelby Burke, Vice President of Finance, and Ronda Hansen, Director of Budget and Grants at EvCC, shared a PowerPoint presentation with the Board.

EvCC will be covering student's debt that was incurred during the pandemic by charging the funds to the institutional side of our federal American Rescue Plan (ARP) grant. We will be covering student debt from Spring of 2020 through Summer of 2021. The debt is worth approximately \$1.2 million

She explained why the college is covering the debt, and the benefits to the students and the college from relieving this debt.

#### This will help:

- Eliminates barriers for students
- Recapture lost tuition revenue for the college
- Clean up student accounts
- Could boost enrollment
