## Presidential Search Update

Denise Gregory Wyatt, vice president of administrative services, shared that the Screening Committee was carefully selected to reflect the various stakeholders and leaders of Everett Community College. Students, classified employees, faculty, administrators, community leaders and community partners are on the Committee. The Committee and all those working on the search attended a Bias in Hiring training in early January. All of the Screening Committee had an equal voice to the process of not only creating the Presidential Profile, but also in the process of reviewing, interviewing and deciding on which candidates were recommended. The Committee reviewed 41 candidates in one week, and then spent a full day discussing and determining who should be brought to campus for interviews. Since the Board of Trustees meeting on March 12, 2019, the Presidential Screening committee had two days of interviews to determine who to recommend to bring to campus for campus forums and an interview. The Screening Committee forwarded to the Board of Trustees its recommendation. The Board reviewed the recommendations and other Presidential Search materials in Executive Session tonight.
