You may not mail, scan, or fax copies of your original documents or a valid unexpired government- issued photo identification without this signed affidavit and use of a Notary Public Official.

OPTION 1: PRESENT DOCUMENTS TO FINANCIAL AID OFFICE

(To be signed at Everett Community College)

The student must appear in person at Everett Community College to provide proof of U.S. citizenship or eligible non-citizenship status directly to a school official in the Financial Aid Office. The school also will request to see a valid unexpired government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport.

- **Acceptable original documents for Proof of United States (US) Citizenship:** US birth certificate, US Passport, Certificate of Naturalization, or Certificate of Birth Abroad
- **Acceptable original documents for Proof of Eligible Non-Citizenship:** Alien Registration Receipt Card (I-551), proof of permanent residency status, or evidence from the Immigration and Naturalization Service that you are in the United States for other than a temporary purpose with the intention of becoming a citizen or permanent resident.

OPTION 2: PRESENT DOCUMENTS TO A NOTARY

- **Acceptable original documents for Proof of Eligible Non-Citizenship:** Alien Registration Receipt Card (I-551), proof of permanent residency status, or evidence from the Immigration and Naturalization Service that you are in the United States for other than a temporary purpose with the intention of becoming a citizen or permanent resident.
- **Valid, unexpired government-issued photo ID:** A driver's license, other state-issued ID, or passport.
